

## CHAPTER 41

### SETTING THE NUMBER OF ALDERMEN TO BE ELECTED FROM EACH ALDERMANIC DISTRICT

[History: Ord 1991-15]

#### **41.01 NUMBER OF ALDERMEN FROM EACH ALDERMANIC DISTRICT.**

There shall be two (2) aldermen elected from each aldermanic district of the City of Richland Center.

#### **41.02 CLASSIFICATION AND YEARS OF ELECTION.**

(1) The aldermanic seats in each district are hereby divided into two (2) classes, to be known as "Seat 1" and "Seat 2" from each district, and each aldermanic seat shall be known and referred to as "District \_\_\_ Seat \_\_\_". Neither seat from in any aldermanic district shall be preeminent over the other seat from that district merely because of their numbering.

(2) Aldermen shall be elected for two (2) year terms, but only one aldermanic seat from each district shall be elected in any year. An Alderman to hold Seat 1 in each aldermanic district shall be elected to a two year term in odd numbered years, and an alderman to hold Seat 2 in each aldermanic district shall be elected to a two year term in even numbered years.

(3) The designation of the Aldermanic Seats of the incumbent Aldermen shall be as follows:

District 1 Seat 1 [Term Expires in April, 1993]: Alderman Robert Schmitz  
District 1 Seat 2 [Term Expires in April, 1992]: Alderman Ronald Sherman

District 2 Seat 1 [Term Expires in April, 1993]: Alderman Susan Marino  
District 2 Seat 2 [Term Expires in April, 1992]: Alderman Thomas McCarthy

District 3 Seat 1 [Term Expires in April, 1993]: Alderman James Burke  
District 3 Seat 2 [Term Expires in April, 1992]: Alderman Harry Peterson

District 4 Seat 1 [Term Expires in April, 1993]: Alderman Edwin Lee  
District 4 Seat 2 [Term Expires in April, 1992]: Alderman Richard Beggs

**41.03 EFFECTIVE DATE OF CHARTER ORDINANCE; REFERENDUM.** This is a charter ordinance and shall take effect 60 days after its passage and publication unless within 60 days after such publication a referendum petition as provided for in s. 66.01(5), Wis. Stats., shall be filed. In the event of the filing of such a petition in such manner, this ordinance shall not then take effect until it is submitted to a referendum of the electors and approved by a majority of the electors voting thereon. Such petition and the proceedings for its submission shall be governed by subsection (2) through (6) of sec. 9.20, Wis. Stats.

**41.04 CLERK TO PUBLISH, FILE AND RECORD.** Upon the adoption of this charter ordinance and the approval thereof by the Mayor, the City Clerk be and he is hereby directed to publish this ordinance as a Class 1 notice under chap. 985, Wis. Stats. Said Clerk is further directed to record and file this charter ordinance as required by sec. 66.01(3), Wis. Stats.
