

EMERGENCY MEETING OF THE COMMON COUNCIL

The Common Council of the City of Richland Center, Wisconsin, met for an emergency meeting in the Council Room of the municipal building on Friday, July 17, 2015 commencing at 4:00 P.M., Mayor Paul F. Corcoran presiding. Alderpersons Michael Kaufman, Susan Fruit, Jay Buchanan Mueller, Marsha Machotka, Lisa Miller, and Marie Rakow were present. Judy Shireman and Bill Kloehn were absent. Mayor Corcoran ascertained from the Clerk that the meeting was properly noticed. Mayor Corcoran noted there was a mix up on dates for the picnic licenses and due to the recent storms he felt it was in the best interest of the residents to call an emergency meeting to address the following items.

CONSIDER AND POSSIBLE ACTION ON APPLICATION FROM RICHLAND CENTER ROCKETS HOME TALENT BASEBALL FOR A TEMPORARY CLASS “B” (BEER) RETAILER’S LICENSE FOR JULY 17TH, 2015 FROM 6:30 P.M. UNTIL 1 HOUR AFTER THE GAME AT NORTH PARK. Motion by Mueller, second by Machotka to approve the license for July 17th at the times specified. Motion carried 4-2 with Alderpersons Rakow and Kaufman voting against.

CONSIDER AND POSSIBLE ACTION ON APPLICATION FROM RICHLAND CENTER ROCKETS HOME TALENT BASEBALL FOR A TEMPORARY CLASS “B” (BEER) RETAILER’S LICENSE FOR JULY 19TH, 2015 FROM NOON UNTIL 1 HOUR AFTER THE GAME AT NORTH PARK. Motion by Mueller, second by Machotka to approve the license for July 19th at the times specified. Motion carried 4-2 with Alderpersons Rakow and Kaufman voting against.

CONSIDER AND POSSIBLE ACTION ON APPLICATIONS FOR MUNICIPAL LICENSES FOR TREE CUTTING. Clerk Jones stated with the storms that arrived earlier in the week there were four applications for tree cutting. She felt it would be beneficial to the residents to approve all of the applications as quickly as possible and they all have provided proof of insurance. Motion by Kaufman, second by Rakow to approve the tree cutting licenses for Mahan tree Service, M and M Tree Service LLC, B & E Tree Service-Bill Kimbler, and KSK Tree Trimming. Motion carried 6-0.
