

CHAPTER 391

REQUIRING A PERMIT TO PLACE A DUMPSTER WITHIN THE LIMITS OF THE CITY

[History: Ord 2001-20]

Section 391.01 shall be adopted, which shall read as follows:

1. No person shall place a dumpster on any street, avenue, lane, alley, or other public place, within the City of Richland Center, without first obtaining a permit to place said dumpster from the Office of the City Clerk.

2. Any person desiring to obtain a Dumpster Permit, shall make application to the Office of the City Clerk, and pay the application fee of Ten & no/100 (\$10.00) Dollars. The applicant shall provide all of the following information on the application:

A. The address where said dumpster shall be placed, and the exact location of placement at said address.

B. The name, address and telephone number where the applicant may be reached during the time of placement of said dumpster .

C. The precise dates of placement of said dumpster, which may not exceed seven (7) days.

3. Upon receipt of an application by the City Clerk, a copy of the application shall be referred to the Chief of Police, or whoever is acting in his place, for approval of the location. In the event the Chief of Police, or the individual acting in his place has a reasonable concern for public safety in the location designated, s/he shall contact the applicant and notify said applicant that the location is considered unsuitable. Applicant may reapply within 14 days, to place the dumpster in a different location, without paying the application fee.

4. In no event, may any dumpster be placed within the City of Richland Center without either of the following:

A. Reflective Barricades clearly marking its location, with one such Barricade being placed in front of the dumpster, and another such Barricade being placed behind the dumpster; or

B. Reflective Tape in a sufficient amount that it can be easily seen during the day or night, both on the front and back portions of the dumpster.

5. Failure to comply with any requirement of Chapter 391 shall result in a forfeiture in the amount of at least \$25.00, but not to exceed \$100.00, in addition to any other liability imposed by law.
