

## CHAPTER 80

### FIXING THE AREA IN WHICH WATER AND/OR SEWER SERVICE IS TO BE EXTENDED BEYOND THE CITY LIMITS

[History: Ord 497]

**80.01** In order to provide adequate fire protection for persons and property within the corporate limits of the City, and so as to insure protecting the public health and safety of the residents of the City without placing an undue financial burden upon the City's taxpayers, and to effectively coordinate water department activities, and for the purpose of conserving the available water supply, and so as to insure against overloading of the sewerage mains and/or sewage treatment plant, it is hereby determined that it is necessary to specifically limit the territory in unincorporated areas which the municipal water utility and municipal sewerage utility holds itself out to serve.

**80.02** The City of Richland Center, as a public water utility and sewerage utility, has not heretofore provided water service and/or sewerage service outside of the corporate limits and the boundaries described hereinbelow. The City of Richland Center herewith acts pursuant to sec. 66.069 (2)(c) of the Wisconsin Statutes to declare the intention of the City to furnish water service and/or sewerage service to a limited area outside of the City and to fix the limits of water service and/or sewerage service in unincorporated areas outside the corporate limit of the City of Richland Center to the territory specifically set forth as follows and as shown on the map, which map is incorporated herein by reference and made a part hereof, to be kept on file by the City Clerk:
