

**SPECIAL MEETING OF THE COMMON COUNCIL  
JOINT WITH THE REDEVELOPMENT AUTHORITY  
May 7, 2020**

The Common Council of the City of Richland Center, Wisconsin, joint with the Redevelopment Authority met via telephone conference on Tuesday, May 5, 2020 commencing at 7:30 PM, Mayor Todd Coppernoll presiding. Alderpersons Ryan Cairns, Scotty Wallace, John Collins, Melony Walters, Travis Wertz, Carson Culver, Susan Fruit, and Karin Tepley were present. Mayor Coppernoll ascertained from the Clerk that the meeting was properly noticed.
